This privacy policy sets out how this website and our company uses and protects any information that you give us. We are committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website or contacting us, then you can be assured that it will only be used in accordance with this privacy statement. What data we collect

We may collect the following information:

- Name and contact information including email address
- Demographic information such as IP address, postcode, preferences and interests
- Other information relevant to Vehicle reminders and marketing, news, offers and promotions

Gain and Record Consent

We will ask for your consent to store your personal data for vehicle reminders and marketing, you can "Opt-in or out at any time", by the following methods:

- Signed consent form when visiting our premises
- Email or SMS contact
- By post

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
- We will use your contact information to send Vehicle Reminders for MOTs, Servicing, Brake Fluid Change, Timing Belt Replacement, Gearbox Oil Change, Power Steering Service and BG Intake System Clean where applicable to you.
- We may use the information to improve our products and services.
- We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided.
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone or mail.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.

Google AdWords

Our website uses the Google AdWords remarketing service to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors. This could be in the form of an advertisement on the Google search results page, Google Shopping or a site in the Google Display Network. Third-party vendors, including Google, may use cookies to serve ads based on someone's past visits to this website. How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use anonymised traffic log cookies via third party applications like Google Analytics to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
